DALIT ASMITA YATRA

Crowds brave rain, new leaders take

BOTAD (GUJARAT), AUGUST 11

"I LEARNT I was a Dalit when I was in Class 3. A Dalit's pain can never be understood by dominant castes. I'm telling my brothers and sisters — why do we need a dominant caste to support our cause? Why can't we raise these issues?" thunders Manisha Mashaal, 27.

Manisha has joined the 10-day Dalit Asmita Yatra, led by former IPS officer Rahul Sharma, activist Nirjhari Sinha and members of her NGO Jan Sangharsh Manch.

Braving the rain, over a hundred people, mostly youths, blocked traffic in Botad — a town of the newly-carved district by

the same name, less than three hours from Ahmedabad city — chanting "Jai Bhim... Jai Bhim". Another hundred people stood on rooftops and balconies to catch a glimpse of the Dalit Asmita Yatra on its way to Una, where, on July 11, seven Dalit youths were flogged for skinning a dead cow.

The rain continues, and so does the march. The participants halt at an open ground where a stage has been set up. The crowd starts to swell even before the floodlights are switched on.

"Do you still want to continue skinning dead animals?" asks activist and lawyer Jignesh Mevani, 35. The crowd responds with a loud "nahi" (no). He asks again, "Don't you want to live with respect and dignity?" The crowd shouts back "haan" (yes). Mevani

asks the crowd to repeat after him, "Gai nu puchhadi tame rakho, amne amari jameen aapo (keep the tail of the cow and give us our land)."

Sharma and Sinha may have floated the idea of the march, but Mevani seems to be a leader in the making. Clad in faded track pants and T-shirt, he is no less persuasive in asking the crowd to join them at Una on August 15.

Former IPS officer Sharma, introducing himself in Gujarati, says, "This is my karmabhoomi. I am a Brahmin but it doesn't make a difference. The concept of upper or lower caste is all in the mind and we need to break it. We are being told what to eat and wear. This is not freedom."

Sharma was SP of Bhavnagar district — of which Botad was then

a part — which remained largely insulated from the impact of the post-Godhra riots. Sharma, who took premature retirement, is now a lawyer in the Gujarat High Court. "This march is not on political discourse. Besides, this forum is for everyone who is oppressed. There is no other agenda," Sinha tells the crowd.

The yatra, which began on August 5 from Ahmedabad, carries two main messages for the Dalits — to leave their traditional work of disposing of dead animals and manual scavenging, and to make their way to Una on August 15. "We have to take revenge for the violence in Una. On August 15 we will give a memorandum to the state government, demanding five acres of land for every Dalit," says Mevani.
